EXPEDITED CONSIDERATION AND FOR ORDER SCHEDULING A LOCAL
PUBLIC HEARING IN ST. CHARLES COUNTY**

Come Now Intervenor City of St. Peters, City of O'Fallon, City of Weldon Spring and St. Charles County, Missouri and for their Motion states:

1. On February 1, 2000, the Commission issued its Order Concerning Test Year, True Up, Accounting Authority Order, and Local Public Hearings.
2. The Order stated, in paragraph 5, that "the Commission will schedule and hold Local Public Hearings in Joplin, St. Joseph, Warrensburg, and Mexico, Missouri. The Commission will issue an Order Setting Local Public Hearings when the preparations are complete."
3. On April 4, 2000, the office of Public Counsel filed its Motion for Order Scheduling Local Public Hearings and Request for Expedited Consideration.
4. Intervenor fully support the Motion of the Office of Public Counsel in this regard.
5. Intervenor further request that the Commission schedule a local public hearing in St. Charles County. There are over twenty-six thousand (26,000) MAWC water customers in St. Charles County, many of whom have expressed great concern over MAWC's current rate case.

WHEREFORE, Intervenor request that the Commission issue its Order Scheduling Local Public Hearings as set forth in its February 1, 2000 Order and that it add St. Charles County as an additional location.
