On October 6, 2017, Wind on the Wires (“WoW”) filed a Motion to Submit Direct Testimony of Michael Goggin. In the motion, WoW explains that it wishes to file direct, instead of rebuttal testimony, of Michael Goggin because doing so would create judicial efficiency, and expedite the case. Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered by the Commission. More than ten days have elapsed since the WoW motion, the Commission issued no order to the contrary, and no party objected to the motion. Thus, the Commission will take up the motion unopposed.

The Commission finds the motion reasonable, and will grant it.

1. The motion to submit direct testimony of Michael Goggin filed by Wind on the Wires is granted.
