FOURTH AMENDMENT TO APPLICATION

COMES NOW Q LINK WIRELESS LCC ("Q LINK" or "Company") and, upon consultation with Staff of the Missouri Public Service Commission ("Staff") hereby requests leave of the Missouri Public Service Commission ("Commission") to submit this Fourth Amendment to its Application for Designation as a Wireless Eligible Telecommunications Carrier ("ETC"). In support of its Third Amendment, Q LINK states as follows:

- 1. On January 4, 2012, Q LINK filed its Application for Designation as a Wireless Eligible Telecommunications Carrier ("Application") with the Commission. Attached as Exhibit 3 to its Application is the Company's proposed Lifeline Application form. While that form is almost identical to the generic Missouri Lifeline Application form that appears on the Commission's website, it contains additional language regarding the applicant's certification that it is not currently enrolled with any other provider's Lifeline program.
- 2. Staff requested that the Company remove the additional language, which it did. The Company filed its Third Amendment to Application, attaching the revised Lifeline Application form as Exhibit A, on April 30, 2012.
- 3. On May 30, 2012, the Missouri Universal Service Fund Board ("MO USF Board") approved a new Lifeline Application form. The MO USF Board clarified on July 17, 2012 that all ETCs are required to use that form. The Company hereby files a new Lifeline Application form as Exhibit A that it intends to use in Missouri and that is compliant with the MO USF Board-

approved form.

WHEREFORE, pursuant to 4 CSR 240-2.080(18), Q LINK respectfully updates its Lifeline Application form that is part of its Application for Designation as a Wireless Eligible Telecommunications Carrier and respectfully requests that the Commission expeditiously approve its Application, as amended, for ETC designation.
