On September 27, 2018, Callabyte Technology, LLC requested designation as both a high-cost and low-income Eligible Telecommunications Carrier (ETC) in all areas in Missouri where Callabyte participates in the Rural Electric Cooperative Consortium and has been allocated Connect America Fund Phase II support.

Notice of the application shall be sent to all incumbent and competitive local exchange carriers certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and direct the filing of a recommendation by the Staff of the Commission.
