ORDER APPROVING TARIFFS PURSUANT TO COMMISSION ORDER

On August 8, 1995, the Commission issued its Report and Order in this matter granting a certificate of convenience and necessity to Missouri Public Service (MPS) to provide natural gas service to the City of Salem, Missouri and the surrounding area. As part of that authorization, the Commission ordered MPS to file tariffs in compliance with the Commission's order prior to commencing operations in the service area.

On July 3, 1996, MPS filed tariffs purporting to comply with the Commission's order of August 8, 1995, and designed to provide for the initiation of gas service to the Salem area. The tariffs carry an effective date of August 2, 1996.

On July 10, 1996, the Staff of the Commission (Staff) filed its recommendation in this matter. After review of the tariff filing the Staff stated that, while the filing does not strictly comply with the time frame as set out in the Commission's order, the Staff has no objection to the filing, as natural gas should be provided to the Salem area as soon as possible. The Staff recommended that the filing be approved as being in

full compliance with the Commission's order of August 8, 1995, and with less than the normal 30-day notice.

The Commission has reviewed the tariff filing and the Staff recommendation in this matter and finds the tariffs, filed July 3, 1996, by MPS, to be reasonable and in full compliance with the Commission's order of August 8, 1995. The Commission will approve the tariffs for service on or after July 15, 1996.

IT IS THEREFORE ORDERED:

1. That the following tariffs, filed July 3, 1996, by Missouri Public Service of Kansas City, Missouri, are hereby approved for service on or after July 15, 1996:
