ORDER DIRECTING FILING

This order directs the Staff of the Missouri Public Service Commission to file a pleading informing the Commission when Staff expects to file its recommendation.

On March 30, 2001, Union Electric Company, d/b/a AmerenUE, filed its application requesting approval to change the single-phase meter testing standard under which AmerenUE currently performs its single-phase meter testing. AmerenUE requests the Commission's approval to change from the MIL Standards, currently used by AmerenUE as a basis for its testing procedure, to the ANSI Standards. AmerenUE states that the ANSI Standards are essentially a modernization of the MIL Standards.

The Commission would be aided in its consideration of this application by Staff's recommendation. Therefore, the Commission shall direct Staff to file a pleading informing the Commission when Staff expects to file its recommendation.

² "ANSI Standards" are American National Standard Institute Sampling Procedures and Tables for Inspection by Attributes and by Variables.
