### ORDER DIRECTING STAFF, PUBLIC COUNSEL, AND AMERENUE TO FILE A RECOMMENDATION

On August 14, 2001, the Office of the Public Counsel filed a motion asking the Commission to suspend a tariff filed by Union Electric Company, d/b/a AmerenUE. The Staff of the Commission filed a response on August 22, in which Staff indicated that Public Counsel, Staff, and AmerenUE had agreed that the tariff should be suspended thirty days, until September 28, to permit the parties to negotiate and come to an agreement regarding the revised tariff provisions. In accord with the request of the parties, the Commission, on August 28, issued an order suspending AmerenUE's tariff until September 28.

September 28 is fast approaching and the Commission has not received a recommendation from any party regarding whether AmerenUE's tariff should be approved, or further suspended. So that the Commission will have the opportunity to act upon this tariff before its period of suspension ends, the parties will be directed to file a recommendation not later than September 24. The parties may file separate recommendations, or, if they are in agreement, they may file a joint recommendation.

#### IT IS THEREFORE ORDERED:

- 1. That not later than September 24, 2001, the Staff of the Commission, the Office of the Public Counsel, and Union Electric Company d/b/a AmerenUE shall file a recommendation regarding approval or further suspension of Tariff Number 200200068, submitted by Union Electric Company d/b/a AmerenUE.
  - 2. That this order shall become effective on September 24, 2001.
