ORDER GRANTING MOTION TO SUBSTITUTE WITNESSES AND TO FILE RELATED DIRECT TESTIMONY

On April 26, 2000, UtiliCorp United Inc. (UtiliCorp) filed a motion asking that the Commission permit Frank A. DeBacker to adopt the previously filed testimony of Robert W. Holzwarth and that Jerry D. Myers be allowed to adopt the previously filed testimony of Dan J. Streek.
