On September 30, 2021, the Commission suspended the procedural schedule and directed the filing of a status report or a settlement agreement. On October 8, 2021, at Ameren Transmission Company of Illinois (ATXI) filed a status report stating that the parties are continuing their settlement discussions and intend to file an agreement that will resolve all the open issues. ATXI requests that the Commission give the parties until October 13, 2021, to finalize and file their agreement. The Commission will grant the request.

THE COMMISSION ORDERS THAT:

1. The parties shall file either a stipulation and agreement resolving the contested issues or a status report no later than October 13, 2021.
2. This order shall become effective when issued.
