AMERENUE'S REPLY TO WAIVER RESPONSES

COMES NOW, Union Electric Company, d/b/a AmerenUE (AmerenUE or the Company), and for its reply to the waiver responses filed by the Missouri Public Service Commission Staff (Staff), the Office of the Public Counsel (OPC) and the Missouri Department of Natural Resources (DNR), states as follows:

- 1. AmerenUE filed its waiver requests on February 24, 2010. Responses to AmerenUE's waiver request were filed by Staff, OPC and DNR.
 - 2. Staff had no objection to any of the waivers requested by AmerenUE.
- 3. OPC had no objection except that it sought clarification of the methodology AmerenUE will use for calculating avoided costs of DSM screening purposes in 4 CSR 240-22.050(2). The specific language sought was included as Attachment 1 to OPC's pleading. AmerenUE has no objection to OPC's clarification and adopts the proposed alternative language in OPC's Attachment 1 as part of its waiver request.
- 4. In contrast to Staff and OPC, DNR suggested changes to 15 of AmerenUE's waiver requests. Of DNR's proposed changes, AmerenUE accepts the suggestion for 4 CSR 240-22.060 (4). AmerenUE opposes the remaining suggested changes for various reasons, which are detailed on Attachment A to this document.
- 5. No other party to this case has filed any objection to the waivers requested by AmerenUE.

6. AmerenUE would point out that its original waiver requests were filed in February and it is now April. While AmerenUE is not asking for an order by a specific date, it has already started work on its 2011 filing and would appreciate the certainty of a prompt Commission decision on these waiver requests.

WHEREFORE, AmerenUE requests the Commission approve the original waiver request, as modified above, for its Integrated Resource Planning process.
