1. On April 21, 2010, the Commission issued an *Order Dismissing Contested Case and Granting Certificate of Convenience and Necessity* and instructed Timber Creek to file revised tariffs no later than June 18, 2010.

2. On May 6, 2010, Timber Creek filed P.S.C. Mo. No. 2, 1<sup>st</sup> Revised Sheet No. 2 cancelling Original Sheet No. 2 (the map), and 1<sup>st</sup> Revised Sheet No. 3 cancelling Original Sheet No. 3 (the legal description).

3. On May 19, 2010, Timber Creek filed an update to the May 6, 2010 filing.

4. Martin Hummel, Utility Engineering Specialist III, has examined Timber Creek's revised substitute tariff sheets P.S.C. Mo. No. 2, 1<sup>st</sup> Revised Sheet No. 2 cancelling Original Sheet No. 2 (the map), and 1<sup>st</sup> Revised Sheet No. 3 cancelling Original Sheet No. 3 (the legal description) and states that to the best of his knowledge, information, and belief, the revised sheets comply with the Commission's *Order*.
