**ORDER DIRECTING NOTICE AND SETTING INTERVENTION  
DEADLINE**

On July 12, 2016, Central Rivers Wastewater Utility, Inc. ("Central Rivers") filed an application with the Missouri Public Service Commission ("Commission") requesting Certificates of Convenience and Necessity ("CCN") to construct, install, own, operate, maintain, control, and manage sewer systems for the public in certain areas of Clay County, Missouri. The requested CCNs would allow the company to provide wastewater treatment and collection system operation and maintenance in areas known as Private Gardens, Berkshire Glen, and Wil Mar Estates. Central Rivers currently provides sewer service for areas adjoining the requested service areas and states additional facilities and financing are not necessary to provide service under the requested CCNs.

If the application is granted, Central Rivers proposes to operate with the rates currently used for its existing certificated areas. Central Rivers requests the requirement in 4 CSR 240-3.305(1)(A)5 to provide a feasibility study be waived. Central Rivers also requests a waiver of the notice requirement in 4 CSR 240-4.020(2), stating that it does not anticipate this proceeding will be "contested."

The Commission will direct notice be given and set a deadline for intervention requests. The Commission will also direct its Staff to file a status report on its review of Central River's application.

**THE COMMISSION ORDERS THAT:**

1. The Commission's Data Center shall provide a copy of this order to the County Commission of Clay County, Missouri, and the Missouri Department of Natural Resources.
2. The Commission's Public Policy and Outreach Department shall make notice of this order available to the members of the General Assembly representing Clay County, Missouri, and to the media serving Clay County, Missouri.
3. Any person or entity wishing to intervene shall file an application to intervene no later than August 12, 2016. Such application shall be filed in the Commission's Electronic Filing Information System.
4. The Commission's Staff shall file either a status report or a recommendation on Central River's application no later than August 19, 2016.
5. This order shall be effective when issued.
