On July 10, 2018, Timber Creek Sewer Company (“Timber Creek”) filed an application with the Missouri Public Service Commission (“Commission”) requesting that the Commission grant it a Certificate of Convenience and Necessity to install, own, acquire, construct, operate, control, manage and maintain a sewer system in Clay County, Missouri.

On September 7, 2018, the Staff of the Commission filed a corrected Staff recommendation to approve the application subject to several conditions. The Commission will direct Timber Creek to file a response addressing the conditions in the Staff recommendation and provide an opportunity for any other party to object or comment on the proposed conditions.

**THE COMMISSION ORDERS THAT:**

1. Timber Creek Sewer Company shall respond to the Staff recommendation, specifically addressing the conditions set out therein, no later than September 17, 2018.
2. Any other party wishing to respond to the proposed conditions in the Staff recommendation shall do so no later than September 17, 2018.

3. This order shall become effective when issued.
