On September 27, 2018, the Missouri Public Service Commission (“Commission”) issued an *Order Granting Certificate of Convenience and Necessity and Granting Waiver*, which required Timber Creek Sewer Company (“Timber Creek”) to submit revised tariff sheets in compliance with the order. On October 5, 2018, Timber Creek filed tariff sheets under Tariff Tracking No. YS-2019-0062 with an effective date of November 4, 2018.

The Commission will direct Staff to file a recommendation regarding the proposed compliance tariff sheets and provide an opportunity for any party to respond.

THE COMMISSION ORDERS THAT:

1. No later than October 17, 2018, the Commission’s Staff shall submit a recommendation regarding the compliance tariff sheets filed under Tariff Tracking No. YS-2019-0062.
2. Any other party wishing to respond or object to the compliance tariff sheets shall do so no later than October 17, 2018.

3. This order shall become effective when issued.
