#### **STAFF'S COMPLIANCE TARIFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, and hereby submits this *Staff's Compliance Tariff Recommendation*.

1. On April 17, 2019 the Commission issued its Order Granting Certificate of

Convenience and Necessity and Waiver ("Order") in this case. This Order directs United

Services, Inc. ("United") to, among other things, file a complete tariff no later than May 7,

2019.

2. United filed its complete tariff on May 6, 2019.

3. On May 7, 2019, the Commission directed Staff to file a recommendation by May 17, 2017 as to whether the tariff complies with its Order.

4. On May 9, 2019 Staff filed a *Request for Amended Order* requesting that the Order be reissued to correct typographical errors that the Commission carried over from Staff's recommendation memorandum. On the same day the Commission ordered any objection to this request be filed by May 17, 2019.

5. After review, Staff concludes that the filings comply with the Commission's Order in every respect, except for the inclusion of the \$42.84 flat rate for commercial and

Countryside subdivision customers. Thus, contingent on the approval of Staff's Request

for Amended Order, Staff recommends approval of:
