## ORDER GRANTING APPLICATIONS TO INTERVENE

On June 16, 2023, Union Electric Company d/b/a Ameren Missouri filed an application with the Commission seeking an order granting certificates of convenience and necessity to construct four solar generation facilities. The Commission directed notice and set a deadline of July 12, 2023, for applications to intervene. On July 12, 2023, Midwest Energy Consumers Group (MECG), Sierra Club, Renew Missouri Advocates d/b/a Renew Missouri, and Missouri Industrial Energy Consumers (MIEC) filed timely applications to Intervene.

On July 13, 2023, during the scheduled prehearing conference, counsel for Ameren Missouri, the Staff of the Commission, and the Office of the Public Counsel stated that they did not object to the four applications to intervene. After considering the unopposed applications to intervene, the Commission finds that MECG, Sierra Club, Renew Missouri, and MIEC have interests which are different from that of the general public and allowing them to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the applications to intervene.

**THE COMMISSION ORDERS THAT:**

1. The applications to intervene of Midwest Energy Consumers Group (MECG), Sierra Club, Renew Missouri Advocates d/b/a Renew Missouri, and Missouri Industrial Energy Consumers (MIEC) are granted.
2. This order shall be effective when issued.

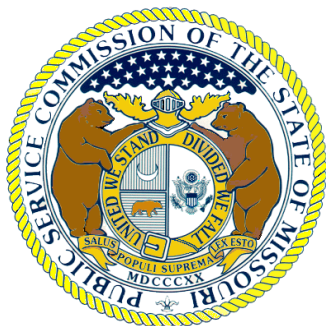
