Subject: Revised Schedule C

Attached to this memorandum is a revised Schedule C incorporating recently obtained residential line counts for Comcast IP Phone, LLC for the exchanges of Buckner, Lake Lotawana, Oak Grove, Odessa, and Pleasant Hill. These line counts were obtained from a Comcast official who verified by signed affidavit the company is providing facility-based residential telecommunications services in these exchanges. Consequently the highly confidential and non-proprietary versions of Schedule C attached to my previously filed September 27, 2007 memorandum should be replaced with the respective versions of Schedule C attached to this memorandum. Besides inserting Comcast's line quantities in these five exchanges, Revised Schedule C removes the previously identified Footnote No. 3 and renumbers the previously identified Footnote No. 4. In addition, all references to "Comcast Digital Voice" in my September 27, 2007 memorandum should be replaced with "Comcast IP Phone, LLC". Comcast IP Phone, LLC rather than Comcast Digital Voice is the legal name of the entity providing local voice service in Missouri. Other minor revisions were made to the schedule clarifying the source of line information for all companies along with assigning Footnote No. 2 to Comcast IP Phone, LLC's line counts. Given these revisions, I am still maintaining the recommendation contained in my September 27, 2007 memorandum. The Commission should make a finding competitive conditions continue to exist in Embarq's competitively classified exchanges.
