ORDER OF RULEMAKING

By the authority vested in the Public Service Commission under section 700.040. RSMo 2016, the commission rescinds a rule as follows:

4 CSR 240-120.080 Commission Reports is rescinded.

A notice of proposed rulemaking containing the proposed rule rescission was published in the Missouri Register on May 15, 2018 (43 MoReg 1011). No changes have been made in the proposed rescission so it is not reprinted here. This proposed rescission becomes effective thirty (30) days after publication in the Code of State Regulations.

SUMMARY OF COMMENTS: The public comment period ended June 14, 2018. and the commission held a public hearing on the proposed rule on June 19, 2018.
