Re: Request Regarding the Name Change of Business Telecom, Inc. d/b/a EarthLink Business to Business Telecom, LLC d/b/a EarthLink Business

Dear Mr. Woodruff:

Business Telecom, LLC d/b/a EarthLink Business (formerly known as Business Telecom, Inc. d/b/a EarthLink Business) (the "Company"), pursuant to 4 CSR 240-2.062, respectfully requests that the Missouri Public Service Commission ("Commission") change the name on the Company's certificate¹ from Business Telecom, Inc. d/b/a EarthLink Business to Business Telecom, LLC d/b/a EarthLink Business.

The change in the Company's name resulted from its conversion from a North Carolina corporation to a North Carolina limited liability company. The conversion was merely a change in corporate form accomplished by the filing of Articles of Conversion in North Carolina and did not entail any merger or other transactions interrupting the existence of the Company. As a result, the customers of the Company continue to be served by the same entity from whom they previously obtained service and continue to receive invoices for services from "EarthLink Business" under the same rates, terms and conditions of service as before the changes. Therefore, notice to customers of the change in name is not necessary.

A copy of the Company's Articles of Conversion and updated authority to transact business from the Missouri Secretary of State reflecting the Company's new name is provided as Exhibit A. An adoption notice and revised tariff title sheet with the Company's new name is attached hereto as Exhibit B.

The Company will review contacts in EFIS for its prior name and make sure they are updated and also insert the contact information for its new name as necessary.

ARTICLES OF ORGANIZATION INCLUDING ARTICLES OF CONVERSION OF BUSINESS TELECOM, INC.

December 20, 2013

Pursuant to §§ 57C-2-21, 57C-9A-01 and 57C-9A-03 of the General Statutes of North Carolina, the undersigned converting business entity does hereby submit these Articles of Organization including Articles of Conversion (the "Articles") for the purpose of forming a limited liability company.

- 1. The name of the limited liability company is "Business Telecom, LLC" (the "Company").
- 2. The Company is being formed pursuant to the conversion of another business entity.
- 3. The name of the converting business entity is "Business Telecom, Inc." (the "Converting Corporation") and the organization and internal affairs of the Converting Corporation are governed by the laws of the state North Carolina.
- 4. A plan of conversion has been approved by the Converting Corporation as required by law.
- 5. There shall be no limit on the duration of the Company.


