**RECOMMENDATION FOR APPROVAL OF TARIFF**

COMES NOW the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel and, for its Recommendation for Approval of Tariff Filing states the following:

1. On March 6, 2009, Mid MO Sanitation LLC ("Mid MO" or "the Company") filed an Application with the Missouri Public Service Commission ("the Commission") seeking to obtain from the Commission a certificate of convenience and necessity to own, operate, maintain, control and manage a sewer system in Callaway County, Missouri.

2. On May 21, 2009, Mid MO, Staff, and the Office of the Public Counsel ("OPC") (collectively referred to as "the Signatories") entered into a Unanimous Stipulation and Agreement in which the Signatories requested that the Commission issue an Order: (1) setting the annual revenue requirement in this case at \$22,500 subject to a customer refund or credit based upon the results of a Small Utility Rate Case; (2) requiring Mid MO to file a Small Utility Rate Case pursuant to 4 CSR 240-3.050 within ninety (90) days of the effective date of the Commission's approval in this case; (3) setting a flat customer charge of \$64.66 per month for residential customers and \$96.98 per month for commercial customers; and, (4) requiring Mid MO to file proposed tariffs reflecting the agreed-upon annual revenue requirement and customer charges by June 1, 2009, with an effective date which is no earlier than July 1, 2009.

3. On June 1, 2009, Mid MO filed a tariff under the terms of the Unanimous Stipulation and Agreement. The tariff filing was designated as Tariff File No. YS-2009-0845 in the Commission's Electronic Filing and Information System and carried an effective date of July 1, 2009.

4. On June 3, 2009, the Commission issued its Order Approving Stipulation and Agreement, in which the Commission granted Mid MO Sanitation LLC a certificate of public convenience and necessity and ordered the Signatories to comply with the terms of the Unanimous Stipulation and Agreement.

5. On June 16, 2009, Mid MO filed a substitute tariff sheet, Tariff Sheet No. 3, in order to include a map of the Company's service area, which was omitted in the June 1, 2009 filing.

6. The Staff has reviewed the tariff filed by the Company on June 1, 2009, and the substitute sheet filed June 16, 2009 (collectively referred to as "the tariff"), and has concluded that such tariff complies with the terms of the Unanimous Stipulation and Agreement and the Commission's Order Approving Stipulation and Agreement.

7. Upon Commission approval of the subject tariff, no further action will be needed in this case and the case may be closed.

8. Attached hereto is the affidavit of Jerry Scheible of the Commission's Water & Sewer Department, wherein he verifies that he conducted a review of the subject tariff and a review of other cases before the Commission, and that he participated in the preparation of this Recommendation for Approval of Tariff.

**WHEREFORE**, the Staff respectfully recommends that the Commission issue an order that: (a) approves the tariff pending in Tariff File No. YS-2009-0845 to be effective for service rendered on and after July 1, 2009; and (b) closes this case.




