NOTICE OF APPLICATION, AND ORDER SETTING DEADLINE FOR INTERVENTION AND DIRECTING STAFF TO FILE RECOMMENDATION

The Commission is directing its staff to file a recommendation on the application of Timber Creek Sewer Company, ("the company") described in the title of this action ("application"), setting a deadline for motions to intervene, and giving notice of the application.

The company filed the application on September 21, 2009, seeking the Commission's permission and approval to construct sewer facilities and provide sewer service. Legal descriptions ("proposed service area") locating such proposed construction and service appear in the application's appendix 2. The names of ten persons residing or owning land in the proposed service area appears in appendix 5.

The statutory requirement of a “due hearing”¹ allows the Commission to grant an unopposed application without conducting a hearing.²

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall serve this notice and order on the:
 - a. Commissioners of the Clinton County Commission, and
 - b. Persons listed in appendix 5 of the application.
2. The Commission’s information officer shall make this notice and order available to the:
 - a. members of the Missouri General Assembly whose districts include the proposed service area described in the body of this order, and
 - b. media serving the proposed service area.
3. Any motion for intervention is due no later than October 13, 2009. Any person filing such a motion shall send the motion to:

4. Staff shall file its recommendation as to the application of Timber Creek Sewer Company that is the subject of this action no later than October 20, 2009.
