On May 1, 2018, Elm Hills Utility Operating Company, Inc. ("Elm Hills") filed an application with the Missouri Public Service Commission ("Commission") requesting that the Commission grant it a Certificate of Convenience and Necessity to provide sewer service to existing developments known as Rainbow Acres and Twin Oaks in Johnson County, Missouri.
