**STAFF COMPLIANCE TARIFF RECOMMENDATION**

**COMES NOW** the Staff of the Missouri Public Service Commission (“Staff”), through the undersigned counsel, respectfully states as follows:

1. On February 24, 2021, the Commission granted Missouri-American Water Company (“MAWC”) a certificate of convenience and necessity (“CCN”) to install, own, acquire, construct, operate, control, manage, and maintain a sewer system in an around Trimble, Missouri and ordered MAWC to file various revised tariff sheets.

2. On March 24, 2021, MAWC filed revised tariff JS-2021-0173 and a *Motion for Expedited Treatment*. On March 25, 2021, the Commission granted MAWC’s motion and ordered Staff to file a recommendation concerning the tariff sheets by March 29, 2021. After discussion with Staff, MAWC filed substitute tariff sheets on March 25, 2021.

3. In *Staff’s Recommendation to Grant Certificate of Convenience and Necessity*, filed December 3, 2020, Staff recommended MAWC revise Sheet No. IN 1.1 and Sheet No. SC 1.1; the Commission’s March 25, 2021, Order also directed MAWC to submit revised tariff sheets including Sheet No. IN 1.1 and Sheet No. SC 1.1. However, following discussion with MAWC, Staff and MAWC now agree that

Sheet No. IN 1.1 and Sheet No. SC 1.1 do not need to be revised. Additionally, Staff and MAWC agree that Map Sheet No. MP 19.1 will remain in the Index “for future use”.

4. Following Staff’s review, with the exceptions listed above, Staff finds that the tariff sheets filed on March 24, 2021, and March 25, 2021, fulfill the intent of Staff’s recommendation, and the Commission’s February 24, 2021, Order. Staff recommends approval of:
