On June 14, 2022, the Commission granted Staff (Staff) an extension from June 15, 2022, until August 15, 2022, to file a recommendation or status report about Confluence Rivers Utility Operating Company, Inc.’s (Confluence Rivers) application for a certificate of convenience and necessity. On August 11, 2022, Staff filed a motion requesting a 14-day extension to file its recommendation. Staff’s motion states that it needs additional time to analyze and finalize its recommendation. Staff represents that Confluence Rivers consents to the extension. The Commission will grant Staff’s motion.

THE COMMISSION ORDERS THAT:

1. Staff’s motion for an extension is granted. Staff shall file its recommendation in this matter no later than August 29, 2022.
2. Any responses to Staff’s recommendation or Confluence Rivers’ application shall be filed no later than September 8, 2022.
3. This order is effective when issued.
