STAFF RECOMMENDATION FOR APPROVAL OF COMPLIANCE TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and recommends that the Commission approve the proposed tariff sheets Confluence Rivers Utility Operating Company, Inc. (“Confluence Rivers”) filed on October 10, 2022, bearing effective dates of November 9, 2022.

1. On October 10, 2022, Confluence Rivers filed its proposed tariff sheets in tariff tracking number YS-2023-0066, with proposed effective dates of November 9, 2022. Also on October 10, 2022, Confluence Rivers moved the Commission for expedited treatment of these proposed tariff sheets so they go into effect with less than 30 days notice on November 1, 2022. Staff has no objection to the tariff sheets being effective with less than 30 days notice.

2. On October 13, 2022 the Commission directed Staff to file a recommendation regarding these tariff sheets by no later than noon on October 17, 2022. Staff reviewed all tariff sheets and concluded that they comply with the Commission’s September 14, 2022 Order Granting Certificate of Convenience and Necessity.

3. Therefore, Staff recommends approval of:
