ORDER APPROVING INTEREXCHANGE CERTIFICATE OF SERVICE AUTHORITY AND ORDER APPROVING TARIFF

PromiseVision Technology, Inc. (PromiseVision), applied to the Missouri Public Service Commission (Commission) on March 8, 2000, for a certificate of service authority to provide intrastate interexchange telecommunications services in Missouri under Section 392.440, RSMO 1994¹. PromiseVision asked the Commission to classify it as a competitive company and waive certain statutes and rules as authorized by Sections 392.361 and 392.420. PromiseVision is an Oklahoma corporation with its principal office located at 12211 North Pennsylvania, Oklahoma City, Oklahoma 73120.

The Commission issued a Notice of Applications for Intrastate Certificates of Service Authority and Opportunity to Intervene on March 14, 2000, directing parties wishing to intervene to file their requests by March 29, 2000. The requirement for a hearing is met when the opportunity for hearing has been provided and no proper party has requested the opportunity to present evidence. State ex rel.

Rex Deffenderfer Enterprises, Inc. v. Public Service Commission,
776 S.W.2d 494, 496 (Mo. App. 1989). Since no one has asked
permission to intervene or requested a hearing, the Commission may
grant the relief requested based on the application.

PromiseVision filed a proposed tariff in conjunction with its application and filed substitute sheets on March 29, 2000. The tariff's effective date is April 24, 2000. PromiseVision's tariff describes the rates, rules, and regulations it intends to use, identifies PromiseVision as a competitive company, and lists the waivers requested. PromiseVision intends to provide interexchange telecommunications services including 1+, Directory Assistance, and Travel Card services.

In its Memorandum filed on March 29, 2000, the Staff of the Commission (Staff) recommended that the Commission grant PromiseVision a certificate of service authority, competitive status, and waiver of the statutes and rules listed in the Notice. Staff recommended that the Commission approve the proposed tariff as amended to become effective on April 24, 2000.

The Commission finds that competition in the intrastate interexchange telecommunications market is in the public interest and PromiseVision should be granted a certificate of service authority. The Commission finds that the services PromiseVision proposes to offer are competitive and PromiseVision should be classified as a competitive company. The Commission finds that waiving the statutes and Commission rules set out in the ordered paragraph below is reasonable and not detrimental to the public interest.

The Commission finds that PromiseVision's proposed tariff details the services, equipment, and pricing it proposes to offer. The Commission finds that the proposed tariff filed on March 8, 2000, shall be approved as amended to become effective on April 24, 2000.

IT IS THEREFORE ORDERED:

- 1. That PromiseVision Technology, Inc., is granted a certificate of service authority to provide intrastate interexchange telecommunications services in the state of Missouri, subject to all applicable statutes and Commission rules except as specified in this order.
- 2. That PromiseVision Technology, Inc., is classified as a competitive telecommunications company. Application of the following statutes and regulatory rules shall be waived:
