On July 16, 1996, Union Electric Company (UE) filed 2nd Revised Tariff Sheet No. 203. The 2nd Revised Tariff Sheet reflects the addition of Cedar Park Place Subdivision as a subdivision for which an unregulated competition waiver has been granted.


IT IS THEREFORE ORDERED:
