ORDER APPROVING TARIFF

On May 28, 1999, RSL COM U.S.A., Inc., (RSL) and One Step Billing, Inc. (OSB), filed an application pursuant to 4 CSR 240-2.060(5)(H) requesting approval of a transfer of assets from OSB to RSL. The Commission issued its *Order Approving Transfer of Assets* on August 24, 1999. RSL acquired OSB's customer base. RSL indicated that it intended to add OSB's services and rates to its tariff. Pursuant to the application and the recommendation of the Commission's Staff, the Commission's order directed RSL to file tariff sheets to incorporate the services and rates of OSB.

On September 3, 1999, RSL submitted a tariff adding OSB's services and rates. At Staff's request, RSL withdrew that filing on September 29, 1999, and resubmitted a new tariff file number 200000342 on October 8, 1999. On November 4, 1999, Staff filed its recommendation stating that it had reviewed the tariff filing and verified that all of OSB's services and rates have been added to RSL's tariff. Staff stated that the tariff filing is in compliance with the Commission's August 24, 1999, order and recommended that Commission approve the following tariff

pages effective November 17, 1999: RSL COM U.S.A., Inc. P.S.C. MO. No. 2, Original Pages 1-52.

The Commission finds that RSL's tariff filing is in compliance with the Commission's order of August 24, 1999, and should be approved. Further, all requirements of the order of August 24, 1999, have been satisfied and this case may be closed.

IT IS THEREFORE ORDERED:

1. That the tariff sheets filed by RSL COM U.S.A., Inc., on October 8, 1999, are approved for service on and after November 17, 1999. The tariff sheets approved are:

2. That this order shall become effective on November 17, 1999.
3. That this case may be closed on November 18, 1999.
