ORDER APPROVING TARIFFS

On June 5, 1991, Wheeling Telephone Company (Wheeling) and Green Hills Telephone Company (Green Hills) filed proposed community optional service (COS) tariffs. The proposed COS tariffs were filed pursuant to the Commission's Order Denying Application For Rehearing And Granting In Part Motion For Clarification issued in Case Nos. TR-91-9 and TR-91-134 which directed Wheeling and Green Hills to file COS tariffs within twenty (20) days from the Order's date of May 17, 1991.

The COS tariffs have a proposed effective date of July 30, 1991, and would implement COS for four routes. Wheeling would implement COS for the Avalon to Chillicothe route (Case No. TO-90-242) while Green Hills would implement COS for the

Mooresville to Chillicothe route (Case No. TO-90-241), the Dawn to Chillicothe route (Case No. TO-90-259) and the Ludlow to Chillicothe route (Case No. TO-90-261).

Wheeling and Green Hills filed identical proposed tariffs. The Commission Staff requested both companies to file substitute sheets to reflect the proper nonrecurring charges and each has done so. On July 22, 1991, the Commission Staff filed a memorandum recommending the Commission approve the tariffs, as amended, in all four cases for service on or after July 30, 1991.

The Commission will approve the tariffs in Case Nos. TO-90-241, TO-90-242, TO-90-259 and TO-90-261 pursuant to its Order of May 17, 1991 in Case Nos. TR-91-9 and TR-91-134, and its Order in Case No. TO-90-232 approving the implementation of Phase II COS routes.

IT IS THEREFORE ORDERED:

1. That the proposed tariffs filed by Wheeling Telephone Company and Green Hills Telephone Company, as set forth below, be hereby approved for service on or after July 30, 1991:

Green Hills Telephone Company  
P.S.C. MO No. 3  
Original Sheet 1 through Original Sheet 35.

2. That this Order shall become effective on July 30, 1991.
