ORDER DIRECTING FILING

On January 4, 2001, the Commission issued an order setting test year and adopting procedural schedule. Among other things, this order directed all parties to file proposed findings of fact and conclusions of law no later than August 3, 2001. The Staff of the Commission, Empire District Electric Company, and the Office of the Public Counsel filed proposed findings of fact and conclusions of law on that date.

The Commission held a true-up hearing on August 23-24, 2001. 1. That each party is requested, but not ordered, to file, as soon as practicable, supplemental proposed findings of fact and conclusions of law that incorporate the issues addressed in the true-up hearing. The proposed findings of fact shall include specific

citations to competent and substantial supporting evidence in the record. Each proposed conclusion of law shall include citations of authority.

2. That this order shall become effective on September 11, 2001.
