**ORDER DIRECTING NOTICE AND SETTING DATES FOR SUBMISSION
OF INTERVENTION REQUESTS AND STAFF RECOMMENDATION**

On September 7, 2017, Missouri-American Water Company (“MAWC”) filed an application with the Missouri Public Service Commission (“Commission”) requesting that the Commission grant it a Certificate of Convenience and Necessity (“CCN”) to install, own, acquire, construct, operate, control, manage and maintain a sewer system in St. Louis County, Missouri. The requested CCN would allow MAWC to provide water service to an existing development known as Radcliffe Place. The Commission will direct that notice be given and set a deadline for intervention requests and Staff recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall provide a copy of this order to the County Commission of St. Louis County, Missouri and the Missouri Department of Natural Resources.
2. The Commission’s Public Information Officer shall make notice of this order available to the members of the General Assembly representing St. Louis County, Missouri and to the media serving St. Louis County, Missouri.

3. No later than September 22, 2017, Missouri-American Water Company and the Radcliffe Place Community Services Association, Inc., shall file suggestions on how to provide notice to the customers affected by the proposed transaction.

4. Any application to intervene shall be filed no later than September 28, 2017.

5. The Commission's Staff shall file a recommendation regarding Missouri-American Water Company's application no later than November 9, 2017.

6. This order shall be effective when issued.
