ORDER DIRECTING CUSTOMER NOTICE

On July 10, 2018, Timber Creek Sewer Company (“Timber Creek”) filed an application with the Missouri Public Service Commission (“Commission”) requesting that the Commission grant it a Certificate of Convenience and Necessity (“CCN”) to install, own, acquire, construct, operate, control, manage and maintain a sewer system in Clay County, Missouri. The Commission issued an order directing notice that also required Timber Creek to file suggestions on how to provide notice to the customers affected by the proposed transaction.

On July 11, 2018, Timber Creek filed a timely response to the order, suggesting that it provide written notice to Star Development Company, which is the only entity affected by the proposed transaction, and file notice of such communication in the docket of this case. Ten days have elapsed, and no party has objected to the Timber Creek response.¹ The Commission finds the Timber Creek suggestion to be reasonable and will adopt it.

¹ Commission rule 4 CSR 240-2.080(13) provides that parties shall be allowed ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission.

THE COMMISSION ORDERS THAT:

1. No later than August 15, 2018, Timber Creek Sewer Company shall provide notice to Star Development Company as described in its response filed on July 11, 2018.
2. This order shall become effective when issued.
