On January 6, 1989, Applicant filed an application with the Commission seeking authority to transport natural gas from Curryville, Missouri to natural gas distribution companies and others in St. Charles County, Missouri.

On August 1, 1989, the Commission issued its Report and Order, effective August 31, 1989, wherein the Commission granted Applicant a certificate of public convenience and necessity to construct, install, own, operate, control, manage and maintain a pipeline originating in Pike County, Missouri, and terminating in St. Charles County, Missouri for the purpose of intrastate transportation of natural gas conditioned upon Applicant's fulfilling eleven (11) conditions set forth in the Commission's order.

On December 27, 1989, Applicant filed a certification of compliance and request to commence transportation with the Commission indicating that all but two (2) of the conditions set forth in the Commission's order of August 1, 1989, had been fulfilled.

On December 29, 1989, the Commission issued its order that Applicant submit final, detailed documentation to the Commission by July 1, 1990 indicating that it had complied with all of the conditions in the Commission's Report and Order of August 1, 1989. On June 5, 1990, Applicant filed an application for an order granting permanent authority. In its application, Applicant detailed its activities in fulfilling the conditions set in the Commission's Report and Order of August 1, 1989.

On July 17, 1990, the Staff filed a memorandum recommending the grant of permanent authority.

The Commission has reviewed the application and the recommendation and has determined that the application should be granted.

IT IS THEREFORE ORDERED:

 The application for an order granting permanent authority filed herein is granted.
