PROPOSED PROCEDURAL SCHEDULE

COME NOW the Director of the Division of Manufactured Homes, Recreational Vehicles and Modular Units of the Public Service Commission ("Director" or "Complainant"), on behalf of himself and the other parties to this case, Discount Manufactured Housing, Inc. ("Respondent"), and the Office of the Public Counsel ("OPC"), collectively "The Parties", and for their *Proposed Procedural Schedule* state to the Missouri Public Service Commission ("Commission") as follows:

1. On February 9, 2001, the Commission issued its *Order Establishing Prehearing Conference and Order Directing Filing of Procedural Schedule* in which The Parties were instructed to submit a proposed procedural schedule by May 10, 2001. The pre-hearing conference in this matter was held on April 26, 2001, pursuant to Commission order, and Complainant and Respondent have been in negotiation since that time. However, no resolution

to the underlying issues in the case have yet been reached. Therefore, The Parties will go ahead and submit a proposed procedural schedule to the Commission at this time.


2. The Parties would respectfully suggest the following procedural schedule to the Commission in this case:

Complainant's Direct Testimony:	June 12, 2001.
Respondent's Rebuttal Testimony:	July 3, 2001.
Complainant's Surrebuttal Testimony:	July 10, 2001.
List of Issues and Order of Witnesses:	July 20, 2001.
Statement of Positions:	July 24, 2001.
Evidentiary Hearing:	July 31, 2001.

WHEREFORE, the Director, on behalf of The Parties, prays that the Commission grant their *Proposed Procedural Schedule*. The Parties further pray that the Commission make whatever other orders and judgments it deems to be just and proper in this cause.


