RESPONDENT'S MOTION TO TERMINATE LETTER OF CREDIT AND TO AUTHORIZE RETURN OF LETTER OF CREDIT

Respondent Amega Sales, Inc. respectfully files this Motion and in support states the following:

- 1. Complainant and Respondent entered into a Stipulation and Agreement in this matter dated May 30, 2008 (the "Stipulation").
- 2. The Commission entered an order approving the Stipulation on July 1, 2008 (the "Order").
- 3. Pursuant to the Stipulation and the Order, Respondent and Greg DeLine ("DeLine") furnished a letter of credit which is explained in more detail in Section 3(e) of the Order. Respondent and DeLine performed their obligations with respect to the letter of credit and provided a letter of credit from Regions Bank meeting the requirements of the Order.

4. The Letter of Credit has been in the possession of the Commission or the

Commission's staff at all times since the time that the Order was entered.

5. The Order provides, in Section 3(e) thereof, that after the expiration of five (5)

years, and when all claims made during that five (5) year period are paid or finally resolved

to the reasonable satisfaction of the Director, the letter of credit may be terminated.

6. The five (5) year period under the Order has expired.

7. At no time did the Director give Respondent notice of any claims for repair under

Section 3(e) of the Order.

8. No draws were made on the letter of credit and no notices of any draws with regard

to the letter of credit were given to Respondent at any time.

9. Respondent respectfully requests that the Commission enter an order terminating

the letter of credit and directing that the original of the letter of credit be returned to

Respondent and permitting Respondent to cancel it and entering any additional orders

amending the Order as the Commission deems necessary.

foregoing.
