ORDER RESCHEDULING SECOND DAY OF HEARING

This order reschedules the second day of the hearing in this case from March 4, 2002, to March 25, 2002.

On January 14, 2002, the Commission issued an order scheduling a second day of hearing for March 4, 2002. On January 23, Hancock Construction Company filed a motion asking the Commission to reschedule the second day of hearing from March 4, to a later date. Hancock's motion indicates that its witness, David Hancock, will be out of state and unavailable to testify until after March 18.

Commission rule 4 CSR 240-2.080(16) provides that parties are allowed not more than ten days from the date of filing in which to respond to any pleading unless otherwise ordered by the Commission. Ten days from January 23 is February 2. No party filed a response within the ten days allowed by the rule. On February 11, Environmental Utilities filed a response in which it opposed Hancock's request to reschedule the hearing.

A short continuance will not be detrimental to any party. The Commission will act to modify the procedural schedule so that the second day of hearings will be held on March 25, rather than March 4.

IT IS THEREFORE ORDERED:

1. That the procedural schedule previously approved in this case is modified to provide that a second day of hearings shall be held on March 25, 2002, beginning at 8:30 a.m.
2. That this order shall become effective on February 24, 2002.

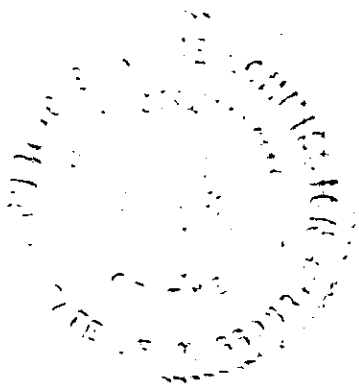
