ORDER APPROVING TARIFFS

AT&T Communications of the Southwest, Inc. (AT&T), a competitive telecommunications company, filed tariffs with the Commission, with an effective date of November 30, 1995, designed to extend its intraLATA discount promotion and intraLATA A&P promotions for AT&T CustomNet, AT&T CustomNet-Option S, AT&T Clear Advantage services, intraLATA Plus Promotion for AT&T CustomNet, and AT&T CustomNet Option S services.

The AT&T CustomNet intraLATA Plus Promotion was initially approved by the Commission to expire on March 31, 1995. The Commission has extended the promotion three times, through October 31, 1995. The remainder of the promotions mentioned above were initially approved by the Commission and extended once, through October 31, 1995. The current tariff proposals are to extend these services through December 31, 1995.

On November 6, 1995, the Staff of the Commission filed its recommendation, stating that it has no objections to the requested extension of the above-named services.

The Commission has reviewed the proposed tariffs and the experience to date with the various promotions stated above and finds the proposed tariffs to be reasonable and in the public interest, and will approve the proposed tariffs for service on or after November 9, 1995.

IT IS THEREFORE ORDERED:

1. That the following tariffs, filed October 31, 1995, by AT&T Communications of the Southwest, Inc. are hereby approved for service on or after November 9, 1995:
