## ORDER CONSOLIDATING TARIFFS AND CLOSING CASE NO. TR-94-366

On June 1, 1994, the Commission established Case No. TR-94-364 to consider a motion filed by the Office of the Public Counsel to suspend tariffs submitted on May 6, 1994, by Southwestern Bell Telephone Company (SWB) designed to establish rate bands for services found to be transitionally competitive. The tariffs apply to MTS, Operator Assistance, 800 service, Common Line 800, WATS, MegaLink II and MegaLink Data. On June 3, 1994, the Mid-Missouri Group of Telephone Companies (Alma Telephone Company, Choctaw Telephone Company, Chariton Valley Telephone Corporation, Mid-Missouri Telephone Company, Mo-Kan Dial, Inc., Northeast Missouri Rural Telephone Company, and Peace Valley Telephone Company) filed a motion to suspend the same tariffs.

Also on June 3, 1994, the Mid-Missouri Group filed a motion to suspend proposed tariffs submitted on May 26, 1994, by SWB designed to establish a rate band for MegaLink III, which had been found to be transitionally competitive. Case No. TR-94-366 was established to consider Mid-Missouri Group's motion. On June 3, 1994, SWB extended the effective date of the two sets of proposed tariffs to July 1, 1994.

The Commission finds that since the two sets of tariffs now have the same effective date, they should be considered in the same docket. The Commission will therefore order the MegaLink III tariffs be placed into Case No. TR-94-364 and Case No. TR-94-366 be closed. This consolidation will allow consideration of all of the tariffs designed to establish rate bands for transitionally competitive services to be considered in one docket.

## IT IS THEREFORE ORDERED:

- 1. That the proposed tariff (9400717) filed by Southwestern Bell Telephone Company designed to establish rate bands for MegaLink III service is hereby consolidated with Case No. TR-94-364.
  - That Case No. TR-94-366 be hereby closed.
  - 3. That this order shall become effective on the date hereof.
