ORDER GRANTING INTERVENTION, SCHEDULING PREHEARING CONFERENCE, AND DIRECTING FILING OF PROCEDURAL SCHEDULE

On May 30, 2001 Union Electric Company d/b/a AmerenUE filed an application for a certificate of convenience and necessity to own and operate a natural gas distribution system in and around the city of Flint Hill. A timely application to intervene was filed by Laclede Gas Company. The application complies with 4 CSR 240-2.075, and Laclede will be granted intervention.

A prehearing conference will be scheduled to afford the parties the opportunity to discuss, define, and possibly resolve the issues presented in this case, and to discuss a procedural schedule. The Commission will also set a date for the filing of a proposed schedule in order to ensure that this case progresses.

IT IS THEREFORE ORDERED:

That Laclede Gas Company is granted intervention.

- 2. That a prehearing conference shall be held on August 9, 2001, beginning at 10:00 a.m. The prehearing conference shall be held at the Commission's office in the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, a building that meets accessibility standards of the Americans with Disabilities Act. - 3. That the parties shall file a proposed procedural schedule no later than August 17, 2001. The procedural schedule shall include dates for the filing of testimony and for a hearing.
 - 4. That this order shall become effective on August 5, 2001.
