ORDER GRANTING JOINT MOTION FOR MODIFICATION OF PROTECTIVE ORDER

On June 1, 2000, the Office of the Public Counsel (Public Counsel), the Staff of the Public Service Commission (Staff), UtiliCorp United Inc. (UtiliCorp) and St. Joseph Light & Power Company (SJLP) filed a Joint Motion for Modification of Protective Order. The Joint Motion requests that the Commission modify the protective order that it has issued in this case to permit the parties to this merger to utilize in Case No. EM-2000-369 (the UtiliCorp-Empire District merger) any data request responses answered by UtiliCorp in this case, as well as data request responses answered by SJLP in this case which are not designated as Highly Confidential or Proprietary by SJLP, provided that any such information is subject to the terms and conditions of the Protective Order issued in Case No. EM-2000-369. On June 2, the Commission issued an Order Shortening Time in Which to Respond to Motion for Modification of Protective Order that directed any party wishing to respond to the

Joint Motion to do so on or before June 8. No party has filed such a response.

The Joint Motion indicates that a modification of the protective order is necessary to allow the parties to avoid duplicating their efforts in the two UtiliCorp merger cases that are currently pending before the Commission. The motion indicates that Paragraph S of the Protective Order would prevent the use in the UtiliCorp-Empire District merger case of highly confidential or proprietary information gathered in this case. Thus, unless the Protective Order is modified, the parties would be required to issue data requests in the UtiliCorp-Empire District merger case that would duplicate data requests already answered in this case.

The relief requested in the Joint Motion is reasonable and is not opposed by any party. The Commission will grant the Joint Motion for Modification of Protective Order.

IT IS THEREFORE ORDERED:

- 1. That the Joint Motion for Modification of Protective Order is granted.
- 2. That the Protective Order previously issued in this case is modified to provide that the parties in Case No. EM-2000-292 may utilize in Case No. EM-2000-369 any data request responses answered by UtiliCorp United Inc. in Case No. EM-2000-292, as well as data request responses answered by St. Joseph Light & Power Company in Case No. EM-2000-292 that are not designated as Highly Confidential or Proprietary by St. Joseph Light & Power Company, provided that any such information is subject to

the terms and conditions of the Protective Order issued in Case No. EM-2000-369.

3. That this order shall become effective on June 27, 2000.
