## CASE NO. TM-88-268

In the matter of Quinter Bosserman d/b/a Peace Valley Telephone Company, a sole proprietorship, Transferor, and Peace Valley Telephone Company, Inc., a Missouri corporation, Transferee, for authority to transfer utility assets.

## ORDER GRANTING APPLICATION

On May 17, 1988, Quinter Bosserman d/b/a Peace Valley Telephone Company, (Transferor), and Peace Valley Telephone Company, Inc., (Transferee), filed their Joint Application seeking authority to transfer Transferor's franchise, facilities and system pursuant to Section 392.300, RSMo (Supp. 1987).

The Commission, upon consideration of the application, the exhibits offered in support thereof and the recommendations of its Staff, determines that a hearing is not necessary to resolve the issues herein and concludes as follows:

Transferor is a telecommunications company and public utility pursuant to Section 386.010, RSMo (Supp. 1987) and is subject to the jurisdiction of this Commission. Transferor's office and principal place of business is located at Peace Valley, Missouri 65788.

Transferee is a corporation duly organized and existing under the laws of the State of Missouri. Transferee's office and principal place of business is located at Peace Valley, Missouri 65788.

Transferor proposes to transfer and Transferee proposes to acquire

Transferor's entire telecommunications franchise, facilities and system. The joint

Applicants state that the Transfer will not be detrimental to the public interest in that Transferee, as a corporation, will carry on the same business and service as Transferor and the same personnel who controlled and operated Transferor will continue to control and operate Transferee. Transferee will continue to utilize the same equipment and no interruption of service or change in service will occur and Transferee proposes to adopt the same tariff rates, rules and regulations which Transferor has on file with the Commission.

On June 27, 1988, the Commission's Telecommunications Department filed a memo recommending approval since Transferee will continue operating telecommunications service with the same equipment and personnel.

The Commission, having considered the application, the exhibits filed in support thereof and the Staff's recommendation, concludes that the application should be granted.

It is, therefore,

ORDERED: 1. That Quinter Bosserman d/b/a Peace Valley Telephone Company, be, and is, hereby authorized to transfer its telecommunications franchise, facilities and system to Peace Valley Telephone Company, Inc.

ORDERED: 2. That Peace Valley Telephone Company, Inc., be, and it is, hereby authorized to acquire and operate Peace Valley Telephone Company's telecommunications franchise, facilities and system.

ORDERED: 3. That the certificate of public convenience and necessity granted to the Peace Valley Telephone Company be, and it is, hereby transferred to Peace Valley Telephone Company, Inc.

ORDERED: 4. That Peace Valley Telephone and Peace Valley Telephone
Company, Inc., be, and they are, hereby authorized to do those acts necessary to
effectuate compliance with this Order.

ORDERED: 5. That nothing in this Order shall be considered as a finding by this Commission of the reasonableness of any expenditures herein involved nor as

an acquiescence in the value placed upon any properties transferred. Furthermore, the Commission reserves the right to consider the ratemaking treatment to be afforded this transaction and its resulting cost of capital in any later proceeding.

ORDERED: 6. That this Order shall become effective on the date hereof.
