### ORDER EXTENDING TIME FOR FILING OF STAFF RECOMMENDATION

On September 27, 2018, Callabyte Technology, LLC filed an application with the Missouri Public Service Commission requesting designation as an Eligible Telecommunications Carrier for the purpose of receiving federal universal service support. The Commission directed its Staff to file a recommendation regarding the application no later than October 31, 2018. On October 31, 2018, Staff filed a *Motion for Extension* indicating that it has not completed its review of the application because of its joint work with the Federal Communications Commission to ensure the application meets all necessary requirements and cannot provide a recommendation before November 30, 2018. The Commission will extend the deadline for Staff to file its recommendation.

#### THE COMMISSION ORDERS THAT:

1. The deadline for the Staff of the Commission to file a recommendation regarding Callabyte Technology, LLC's application is extended to no later than November 30, 2018.
