On September 27, 2018, GoSEMO, LLC requested designation as both a high-cost and low-income Eligible Telecommunications Carrier (ETC) in all areas in Missouri where GoSEMO participates in the Rural Electric Cooperative Consortium and has been allocated Connect America Fund Phase II support.

Notice of the application shall be sent to all incumbent and competitive local exchange carriers certificated to provide service in Missouri. The Commission will also set a deadline for intervention requests and direct the filing of a recommendation by the Staff of the Commission.

THE COMMISSION ORDERS THAT:

1. The Commission’s Data Center shall send notice of this application to all eligible telecommunications carriers certified to provide service in Missouri.
2. Any request to intervene shall be filed with the Commission no later than October 10, 2018. Such applications shall be filed with:
