STAFF RECOMMENDATION FOR APPROVAL OF TARIFFS

COMES NOW the Staff ("Staff") of the Missouri Public Service Commission ("Commission"), by and through counsel, and hereby recommends that the Commission approve tariff PSC MO No. 2 submitted in the above referenced case and bearing Tariff Tracking No. YS-2013-0258. In support of this recommendation, Staff respectfully states:

- 1. On January 31, 2012,¹ R.D. Sewer Co., L.L.C. ("Company") initiated a small company rate increase action pursuant to Commission Rule 4 CSR 240-3.050.
- 2. On December 6, the Company filed tariff PSC MO No. 2 in Tracking No. YS-2013-0258 in compliance with the terms of the *Unanimous Agreement Regarding Disposition of Small Sewer Company Revenue Increase Request ("Unanimous Agreement")*. Staff, with approval of the Company and the Office of Public Counsel ("Public Counsel"), moved the Commission to approve the tariffs on less than thirty days' notice. All parties have agreed to an early effective date of December 14, 2012.
- 3. The Commission has the authority to approve the proposed tariff PSC MO No. 2 pursuant to Section 393.140(11), RSMo (2000).
- 4. James M. Russo, Rate and Tariff Examination Supervisor in the Water & Sewer Department of the Missouri Public Service Commission, participated in the

review of tariff PSC MO No. 2 filed in Tracking No. YS-2013-0258, and states that to the best of his knowledge, information and belief, the tariff as set forth in Paragraph 2 is true and correct and complies with the terms of the *Unanimous Agreement* filed in this case. The *Affidavit of James M. Russo* is attached here as Appendix A and incorporated by reference.

WHEREFORE, Staff recommends that the Commission issue an order approving the *Unanimous Agreement* filed in Case No. SR-2012-0263 and tariff PSC MO No. 2 pending in Tariff Tracking No. YS-2013-0258 to become effective December 14, 2012.
