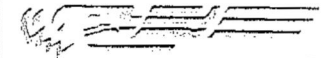

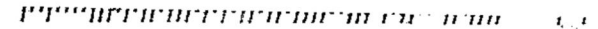

**NOTICE OF REQUEST TO CANCEL ETC DESIGNATION  
AND ORDER SETTING INTERVENTION DATE**

On October 29, 2021, Missouri RSA 5 Partnership a/k/a Missouri RSA No. 5 Partnership d/b/a Chariton Valley Wireless Services ("MO5") filed a letter with the Commission to provide notice of its relinquishment of its designation as an Eligible Telecommunications Carrier ("ETC"), effective December 31, 2021. On November 19, 2021, the Staff of the Commission (Staff) filed its *Staff Motion for Company to Supplement Request*. The Commission designated MO5 as an ETC in Case No. TO-2006-0172, with an effective date of October 1, 2006.

The Commission does not have specific rules concerning relinquishing ETC authority but relies on 47 U.S.C. Section 214(e)(4), which states, in part,

Prior to permitting . . . an eligible telecommunications carrier to cease providing universal service in an area served by more than one eligible telecommunications carrier, the State commission . . . shall require the remaining eligible telecommunications carrier or carriers to ensure that all customers served by the relinquishing carrier will continue to be served, and shall require sufficient notice to permit the purchase or construction of adequate facilities by any remaining eligible telecommunications carrier. The State commission . . . shall establish a time, not to exceed one year after the State commission . . . approves such relinquishment under this paragraph, within which such purchase or construction shall be completed.

Therefore, the Commission issues this notice that MO5 intends to relinquish its wireless ETC designation. The Commission will also set a deadline for filing requests for intervention.

**THE COMMISSION ORDERS THAT:**

1. The Data Center of the Commission shall send a copy of this notice to each eligible telecommunications carrier (ETC) in the state of Missouri.
2. Any objections to this request for relinquishment or requests for intervention shall be filed no later than December 7, 2021.
3. This order shall be effective when issued.




