On July 16, 2018, TracFone Wireless, Inc. ("TracFone") filed a motion to provide lifeline service through additional brands. The Commission set an August 17, 2018, deadline for the Commission's Staff to file a recommendation. On August 16, 2018, Staff filed a status report stating that TracFone had until August 20, 2018, to answer Staff's data requests. Staff requests the Commission issue an order allowing it to file a recommendation by September 17, 2018. The Commission will establish that date for Staff to file its recommendation.

THE COMMISSION ORDERS THAT:

1. No later than September 17, 2018, the Staff of the Commission shall file its recommendation regarding this matter.
2. This order shall be effective when issued.


