**REPLY TO STAFF RESPONSE
AND REQUEST FOR EXPEDITED TREATMENT**

COMES NOW Union Electric Company, d/b/a Ameren Missouri (Ameren Missouri or the Company), and for its Reply to Staff Response and Request for Expedited Treatment (Reply), states as follows:

1. On December 12, 2013, the Missouri Public Service Commission (Commission) approved a tariff filed by Ameren Missouri. The Commission also granted a variance that had been requested by the Company.

2. On December 20, 2013, Ameren Missouri filed an application for rehearing (rehearing request) and asked that the Commission expand the variance. At the Commission's order, Staff filed a response which agreed with only a portion of Ameren Missouri's rehearing request.

3. On January 16, 2014, the Commission ordered Ameren Missouri to reply to Staff's response.

4. After due consideration, Ameren Missouri agrees that Staff's suggestion to modify the previously approved tariff would eliminate the need for a portion of its rehearing request. Concurrent with this filing, Ameren Missouri has filed new tariff sheets to implement that change. Staff's suggested language was modified slightly, in order to use defined terms contained within the tariff.

5. Ameren Missouri has shared the new tariff sheets with Staff and counsel for Staff has authorized the Company to state that it does not oppose this change.

6. Ameren Missouri requests expedited treatment so that the tariff sheets can become effective no later than February 6, 2014. The urgency stems from the fact that the rebate pool process is already underway and the Company desires for the correct version of the tariffs governing this process to be in effect.

WHEREFORE, Ameren Missouri requests the Missouri Public Service Commission approve the variance request so that it is effective no later than February 6, 2014, as set forth above.
