REPLY OF ROLLA TO RESPONSES OF OTHER PARTIES

Comes now the City of Rolla, Missouri (Rolla), by and through Rolla Municipal Utilities (RMU), and, for its Reply to the Responses filed on August 2 and 3, 2010 by Staff, Office of the Public Counsel, and Donna D. Hawley, respectfully states as follows:

1. None of the responses contain any legal argument that justifies the stated position of Staff that Ms. Hawley should be entitled to view HC material as a *pro se* litigant. Therefore, the Commission should rule that Staff is not permitted under the Commission's confidentiality rule to provide her with HC material in its possession in this proceeding.

2. In the alternative, if the Commission is nevertheless inclined to treat Ms. Hawley as somehow qualified under the rule to be provided HC material, the Commission should only do that after careful review of her statement in paragraph 6 of her August 3 response where she says: "During my tenure on Council I did not ever divulge closed information or actions held in executive session to the public with one exception." Rolla believes that "one exception" is one too many when it comes to divulging closed records.
