## ORDER GRANTING WAIVER OF SPECIFIC STATE LIFELINE PROGRAM CRITERIA

Issue Date: October 3, 2018 Effective Date: November 2, 2018

On July 16, 2018, TracFone Wireless, Inc. ("TracFone") filed its *Motion to Provide Lifeline Service Through Additional Brands* requesting the Commission issue an order permitting TracFone to offer Lifeline service through additional brand names beyond its SafeLink Wireless brand. Specifically, TracFone asks to use the brand Walmart Family Mobile. TracFone was previously approved as an eligible telecommunications carrier (ETC) in Case No. TA-2009-0327.

The Commission issued an order directing notice to all eligible telecommunications carriers for Lifeline support authorized to provide service in Missouri. The Commission set an intervention deadline of July 27, 2018. No intervention requests were received.

The Commission ordered its Staff to file a recommendation regarding TracFone's request no later than August 17, 2018. Staff timely filed a recommendation stating that Commission rule 4 CSR 240-31.130(2)(G) prohibits an ETC from the use of additional brand names.

In TO-2014-0020, the Commission approved a stipulation and agreement between Staff and TracFone whereby TracFone agreed to not offer or provide Lifeline service under any other name than its Commission approved ETC designated name: SafeLink Wireless. Staff's current recommendation represents a change in Staff's position as put forth in the 2013 stipulation and agreement.

Staff generally supports limiting an ETC's name usage to minimize confusion as to who is providing the service. However, TracFone's marketing sufficiently informs consumers that the underlying service is being provided by TracFone. Under these circumstances, Staff believes it is appropriate for the Commission to grant a waiver of its rule under narrow circumstances when a company's use of an additional brand name is of an entity owned and operated by the company.

Commission Rule 4 CSR 240-31.130(4)(D) allows the Commission to grant a waiver of any provision of 4 CSR 240-31.010 through 4 CSR 240-31.130 for good cause shown. The Commission finds that because suitable steps exist to avoid confusion as to who is providing the service, and because Walmart Family Mobile is owned and operated by TracFone, good cause to grant a waiver exists. Additionally, because the Commission currently recognizes the company as TracFone Wireless, Inc. d/b/a SafeLink Wireless, the company name should revert to TracFone Wireless Inc., as that name best encompasses the use of multiple brand names offering Lifeline service under TracFone. Therefore, the Commission will grant the waiver with conditions.

#### THE COMMISSION ORDERS THAT:

TracFone is granted a waiver of Commission Rule 4 CSR 240-31.130(2)(G),
 and may offer Lifeline service under additional names for entities owned and operated by
 TracFone.

2. TracFone is to provide advance notice to the Public Service Commission of additional brand names by filing notice of any additional names 30 days prior to the use of such names in Missouri.

3. The name of the company as recognized by the Public Service Commission is hereby changed from TracFone Wireless, Inc. d/b/a SafeLink Wireless to TracFone Wireless, Inc.

- 4. TracFone shall maintain Lifeline service using the d/b/a SafeLink Wireless.
- 5. This order shall become effective on November 2, 2018.
