## **CLARIFICATION REQUEST**

**COMES NOW** the Staff of the Missouri Public Service Commission ("Staff"), by and through counsel, states the following:

- 1. On May 5, 2023, DISH Wireless LLC d/b/a Gen Mobile requested that the Missouri Public Service Commission ("Commission") designate it as an Eligible Telecommunications Carrier (ETC) for the purpose of providing Lifeline service to qualifying Missouri consumers.
- 2. On June 8, 2023 Staff filed its *Recommendation* for the Commission to grant ETC status to DISH Wireless LLC d/b/a Gen Mobile.
- 3. On July 22, 2023, the Commission granted ETC designation to DISH Wireless LLC but the Commission's *Order* did not incorporate d/b/a Gen Mobile.
- 4. If a company intends to use a d/b/a name Missouri Commission rules contemplate the inclusion of a company's d/b/a name in the Commission's order granting ETC designation.<sup>1</sup> Staff respectfully requests that the Commission issue an Order clarifying the inclusion of Gen Mobile within the company's full name.
